

# CARFAC response to COVID-19

## To our community of artists, cultural workers, and organizations:

Please know that we at CARFAC stand in solidarity with your concerns over COVID-19 and the ever-changing situation we are facing here at home and abroad. We are committed to providing our community and colleagues with the best available resources and we urge everyone to follow the recommended safety precautions as advised by the [Public Health Agency of Canada](#).

As the situation continues to unfold, we have a few recommendations:

**[Begin tracking your income losses](#)** due to cancelled exhibitions, reproductions, or travel related to your work. We are in talks with the Government and with other arts organizations to come up with a plan on how to support artists, cultural workers, and service organizations. This data will help determine what that will look like.

**Stay connected to your communities** by telephone, email, letter writing, video-chat, and online groups. We should physically distance ourselves, but it's important to stay [socially connected](#). (ie: [your CARFAC provincial office](#)). Most of us are working from home and still running "business as usual" – but with modified services.

**Go directly to reputable and accredited sources for information.** CARFAC National will regularly share information on social media, and here are a few resources that you may find helpful:
